[01] SIGNIFICANT ACCOUNTING POLICIES:-

METHOD OF ACCOUNTING:-

The Trust follows the Mercantile System of Accounting and recognizes Income and Expenditure on Accrual basis. The accounts are prepared on historical cost basis. Trust is following consistency, accrual basis and going concern convention of accounting. Trust also follows the Accounting Standards prescribed by The Income-Tax Act 1961. Accounting policies not referred to otherwise are consistent with generally accepted accounting principles. As informed by the management, there is no change in method of accounting employed as compared to method employed in immediately preceding previous year.

CURRENT ASSETS:-

Current Assets, if any, have been valued at their realizable value or cost price whichever is lower.

INCOME AND EXPENDITURE:-

Revenues / Incomes and costs / expenditure are generally accounted on accrual basis, as they are earned / incurred.

[02] Income and Expenditure Account—Rs. 1,04,747.90: -The deficit of Rs. 2,584.70 for the year is credited to the opening balance of Rs.1,07,7332.60 taking Closing balance to Rs. 1,04,747.90.

[03] Other liabilities-Rs. 14,000.00: - This includes the amounts of Professional Fees of payable for the year 2020-2021 for auditing, certification and preparation and / or uploading of income tax returns, reports, budgets etc. on the government sites.

<u>04</u> Donations received: -During the year, trust has raised the fund and donations of Rs. 2,22,229.60 and spent Rs. 2,30,118.30 on the objects of trust.

[05] Registration under section 12A and Approval under Section 80G: - Trust has obtained the registration under section 12A and approval under Section 80G from the Department of Income-Tax-under the amended provisions of the Income-Tax Act, 1961.

[06] Legal compliances: In spite of full absence of independent infrastructural facilities of the trust of its own, trustees are making efforts to comply with the provisions of the laws as are applicable to the trust to the maximum possible extent. SUBJECT: -AUDIT OF YOUR TRUST FOR THE YEAR 2020-2021.

<u>SUGGGESITONS</u>: -As referred to by us in our report of even date, we are giving below the suggestions in relation to the working of the Trust as under: -

- [01] All important documents in original should be kept in locker in the office of Trust / Bank locker under the control of designated office bearer.
- [02] Financial powers of various office bearers with reference to capital and revenue expenditure need to be defined.
- [03] **PROCEEDING BOOKS:-**Proceeding book should be preferably written manually and regularly and got duly signed. However, if the printed pages are pasted to the proceedings books, the same must be cross-sealed and cross-signed by the authorized persons as this is a permanent record. Proceedings should be self-explanatory, brief and up to the point only, including the names of dissenting members, if any. All events during the year need to be properly recorded in the minutes suitably indicating the names of proposer, seconding member etc. Copies of the notices of the meetings with acknowledgements thereof and attendance also should be updated.
- [04] No vouchers should be accepted on papers marked like Quotation, Estimate, On approval etc. except on papers like Cash memo or tax invoice only. All vouchers should be in the name of the trust, signed by both-receiver and giver- under the revenue stamp, if required, supported by the cash memo / tax invoice and followed by a short narration thereon and thereof in the software. No papers like 'estimate / quotation / on approval memo' etc. should be accepted as the voucher, cash memo or the tax invoice. Some payments are also made on internal vouchers only and in cash. There are such deficient vouchers. We have relied on the authentications made by the management in such cases.
- [05] All the assets belonging to the Trust need to be got recorded in the Schedule A in the office of Assistant Charity Commissioner, Pune Region, Pune-411 001. This reporting also includes filing all the change reports with the said office.
- [06] Latest Schedule A from beginning of Charity Commissioner be obtained from the office of Charity Commissioner be obtained and kept on record.
- [07] Income-tax may be deducted at source as and when applicable.
